The following items are corrections and/or additions to the above referenced project.

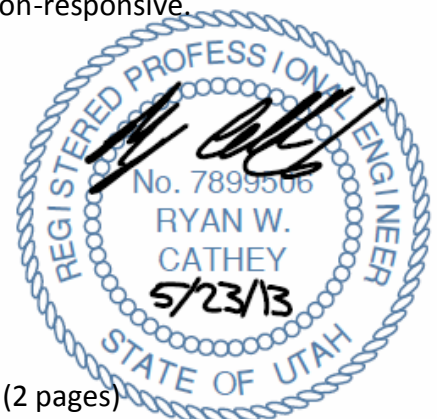

2. Section 00200 – Revise 1.01.E to read: “ENGINEER: Stanley Consultants”
3. Add the following section to the Project Manual:
  - a. Section 00456 – Conflict of Interest – Disclosure Statement (2 pages)  
Bidder shall complete document and submit with Bid along with other required documents per Sections 00200 and 00410.
4. Section 00520 – Replace the first line of 3.01 with the following:  
“Stanley Consultants (Engineer) is to act as Owner’s”
5. Delete the following pages from the Project Manual:
  - a. Section 00615 – Payment Bond, page 3 of 3, page 2 of 4, and page 3 of 5.  
(Section 00615 – Payment Bond, pages 1-3 of 3, is still valid and binding.)
6. Section 00800 – SC-5.04.C.5
  - a. Revise SC-5.04.C.5.a to read: “Stanley Consultants (Engineer)”
  - b. Revise SC-5.04.C.5.c to read: “Summit Mountain Holding Group, LLC (Owner of Property)”

Bidder shall acknowledge receipt of this addendum on page 2 of Document 00410 – Bid Form. Bids received without acknowledgement of addenda may be considered non-responsive.
